

Basketball Elite Development Institute (B.E.D.I) Terms and Conditions

1. Registration and Payment:

Participants must complete the registration process and submit payment to secure a spot in the camp.

Payment plans and financial assistance may be available upon request, subject to approval.

Full payment is due before the start of the camp, unless otherwise arranged and approved by B.E.D.I.

2. Cancellation and Refund Policy:
